Minutes

- o Minutes from 1/16/2018 were approved at 1840
- CPAP trial update: The state has approved forms that was submitted to them to continue with the trail study, anticipates 1 year unless we have enough data that we can end early
- CPAP education form, skill tracking form, patient tracking form (attached): These forms must be used in completing the education of basic providers and training/testing of providers. The tracking form needs to be provided to the EMS coordinators ASAP so those reports can be pulled quickly. You may fax to Tanya on her secured Fax, Bailey was to check with Chris if he had a secured fax. Services will need to go back into the 2017 records and pull those pts that could have benefited from CPAP. It will be up to those that are reviewing the final records to be submitted to determine the reports that meet the exclusion criteria.
- What CPAP device does each service currently carry: Flow Safe II
- CPAP trial agreement form for providers to sign: Bailey highlighted the points of the agreement stating that this agreement is for those services that want to participate. It acknowledges that services will remain for the length of time; if they need to drop out of the study a notice will be provided. It also addresses the responsibility of the services following the protocols set and completing the required education. Also has how the materials and billing will be handled so there is no to very little cost of those participating. This is a copy for any required parties to view prior to signing. We will send out a formal one and will need these back asap so we can begin training.
- O How we will handle the mask: The basic service can either purchase the Flow Safe II from a supplier or possible their responding ALS provider. If they cannot purchase notify their coordinator so one can be purchased for you. When the BLS unit uses the mask the ALS unit will replace the mask with one of theirs. The ALS unit will then bill as normal for use of the CPAP mask. And replace their stock as done in the past.
- Services willing to train services: Education must be completed for basic service providers before we begin. Once agreements are signed we can begin education. To help in moving through this quickly, if your ALS department is interested in assisting in education contact your coordinator so we can help arrange. This will help to move us forward.
- Calling closest department: We discussed calling the closest department. It was found in discussion that some departments were lead to believe that dispatch would do this automatically. It is believed that some department have a list at dispatch that were submitted in years past based on contracts, not necessarily he closest department. It is recommended looking into this for your department. It is important to remember that dispatch might be working on various calls from



various computers, you as a department might have to make that request of the closest service.
